2025 LETTER OF AGREEMENT BETWEEN THE CITY OF LONG BEACH AND THE LONG BEACH MANAGEMENT ASSOCIATION

RE: LBMA POSITION SALARY GROUPINGS

This Letter of Agreement is entered between the City of Long Beach ("City") and the Long Beach Management Association ("LBMA"), (collectively "the Parties").

WHEREAS, the Parties have entered into a Memorandum of Understanding (MOU) covering the period of October 1, 2023 to September 30, 2026, which includes a provision for Salary Groupings of LBMA represented classifications.

WHEREAS, the LBMA MOU, Article Two, Section B indicates that all represented classifications included in Appendix A and positions that have not been designated to a salary grouping/range will be appointed to a salary grouping for their classification as outlined in the salary grouping/range tables in Appendix D. Therefore, the previously ungrouped Superintendent – Refuse & Street Sweeping, the new classification, Manager - Pier H Bureau, approved by City Council on September 10, 2024 and the new/revised classifications in the Harbor Department's Salary Resolution approved by City Council on December 3, 2024, will be included in the LBMA MOU Appendix A and D.

WHEREAS, the Parties have met and discussed modifications of the salary groupings as follows:

- A. Change specific position titles in Appendix A of the MOU.
- B. Designate a new FY25 classification to the appropriate salary range/grouping.
- C. Designate ungrouped position (Appendix E) to the appropriate salary range/grouping.

NOW THEREFORE, the Parties agree to the following:

- A. Appendix A in the LBMA MOU will have changes to titles as listed in Appendix A Addendum of this LOA, as follows:
 - 1. Incorporate a new FY25 General City management classification, Manager Pier H Bureau, effective December 14, 2024.
 - 2. Incorporate new FY25 and revised Harbor Department classification titles, effective September 21, 2024.
 - 3. Revised General City classification title change from Superintendent Refuse & Street Sweeping to, Superintendent Street Sweeping & Parking Operations, effective February 8, 2025;
- B. Appendix D in the LBMA MOU will be revised with the following changes listed in Appendix D Addendum of this LOA:

- 1. Designate a new FY25 General City classification into assigned salary grouping based on scope, complexity of work and internal equity, effective December 14, 2024;
- 2. Designate new FY25 Harbor Department classifications into assigned salary groupings based on scope, complexity of work and internal equity, effective September 21, 2024;
- 3. Designate Superintendent Refuse & Street Sweeping classification that was listed in Appendix E of the LBMA MOU into assigned salary grouping based on scope, complexity of work and internal equity, and revise this title to Superintendent Street Sweeping & Parking Operations effective February 8, 2025.
- C. This Letter of Agreement shall not change any Memorandum of Understanding (MOU) provisions other than as outlined above.
